Announcement of Promotion Process for Driver/Operator

Manchaca Fire Rescue will be holding a promotion process to establish an eligibility list for the position of Driver/Operator (DO). The process is open to full and part-time personnel that meet the following prerequisites:

- They are a full time or part time member of Manchaca Fire Rescue as of 8/1/2017
- At the time of the exam, holds TCFP DO certification and a Texas Class B Driver's License
- Is not otherwise restricted from participation in the promotion process by disciplinary action

The process will consist of a 100 question, multiple-choice exam and a practical skills evaluation. The written test score will be weighted to 50% of the final process score. The practical skills evaluation score will be weighted to 50% of the final process score. Exam participants must pass the written exam to proceed to the practical skills evaluation. A minimum of two members must pass the written exam for a promotion list to be established. The list will be finalized upon conclusion of the practical skills evaluation and will be in effect for one year from the date of the written exam. Any pending appeals or disputes will have no bearing on the effective date of the list.

Persons wishing to participate in the promotion process must notify Battalion Chief Poole of their intent to test via email at cpoole@tcesd5.org by October 1st, 2017.

Minimum passing score to proceed in the process: 70%

Practical Skills:

Minimum passing score to proceed in the process: None

Practical skills evaluations:

- 1. Initial attack on tank water with transfer to hydrant supply
- 2. Tank transfer as 2nd engine on scene at an offensive working fire
- 3. 180° turn around in a restricted space with backing guide
- 4. Maneuvering around roadway obstructions with backing guide
- 5. Driving through an area with restricted horizontal clearance

Each skill will have assessment steps with point values assigned. The candidates score will be a percentile score of their total points accumulated through all 5 evolutions against the total points possible. Candidates are be expected to be able to operate either engine 501 or engine 511 in the performance of these skills.
