- THE POINT COMMUNITY CHURCH IT WAS DISCOVERED THE CHURCH UNLAWFULLY BUILT THREE ROOMS INSIDE THE MAIN BUILDING AND THERE IS NO SPRINKLER COVERAGE. THE SPRINKLER SYSTEM IS CURRENTLY TAGGED AS DEFICIENT AND WAS REPORTED TO THE COUNTY FIRE MARSHAL'S OFFICE IN


- SEPT 2024 BY THE SPRINKLER CONTRACTOR AND NO ACTION TAKEN BY THE TCFMO UNTIL I BROUGHT IT TO THEIR ATTENTION.
- SOUTHWEST CHRISTIAN CHURCH AT 10500 OLD MANCHACA RD: FIRE LANES ARE NOT MARKED CORRECTLY AND CURRENTLY UNENFORCEABLE. WORKING WITH THEM ON TIMELINE TO GET RESTRIPED
- ST. JOHNS PRESBYTERIAN RENTING THEIR OFFICES TO HABITAT FOR HUMANITY HOWEVER THE CHURCH HAS DECIDED TO SHUT DOWN EFFECTIVE MARCH 2025;
- HABITAT FOR HUMANITY AND THE CHURCH WILL BE MOVING OUT; WILL NEED TO COORDINATE WITH NEW OWNERS/TENANTS ON FIXING MINOR ITEMS.



- DESIGNED SOCIAL MEDIA CONTENT FOR HEATER SAFETY;

- WORKING WITH TRAVIS COUNTY AND 911 ADDRESSING ON RESIDENTIAL ADDRESSING ISSUES FOR RESIDENTS ON DOUBLE ELM DR. THESE ADDRESSES WILL BE CHANGED TO BETHEL CHURCH RD. SEVERAL ADDRESSES ON BETHEL CHURCH RD NEED TO BE FIXED TO PREVENT EMERGENCY RESPONSE DELAYS.




# HAYS COMMONS DEVELOPMENT ON BLISS SPILLAR:
